## **DELAWARE DIVERSITY JOB FAIR FOR SECOND- AND THIRD-YEAR LAW STUDENTS**

The Delaware Diversity Job Fair Committee of the Delaware State Bar Association invites you to apply to participate in the **33rd Annual Delaware Diversity Job Fair (DDJF)** to be held **VIRTUALLY** on **Saturday, July 13, 2024**. The **DDJF** was founded by a consortium of Delaware law firm, corporate, and public sector/interest legal employers committed to promoting diversity, equity, and inclusion in the Delaware bar by encouraging interested law students to explore summer and full-time opportunities to work in Delaware.

The **DDJF** is an invitation-only event limited to rising 2L/3LED (2026) and rising 3L/4LED (2025) students interested in summer or full-time employment opportunities with law firm, government, and/or public sector/interest employers in Delaware.

The **DDJF** format is a series of virtual interviews, hosted via FloRecruit, that take place between 10:00 am ET and 1:30 pm ET. Pre-selected students will receive an invitation to attend the **DDJF** in late June and be asked to accept or decline by June 28. Additional information about the **DDJF**, including confirmed interview timing and virtual access details, will be provided to participating students in early July.
